¹ Includes all Medicare beneficiaries who were eligible for or enrolled in Medicare on or after January 1, YYYY.

² In any given year a beneficiary may be counted in more than one Assessment Type category.

³ MDS - Minimum Data Set: Assessment data collected by nursing homes.

⁴ OASIS - Outcome and Assessment Information Set: Assessment data collected by home health agencies.

⁵ IRF-PAI - Inpatient Rehabilitation Facility Patient Assessment Instrument: Assessment data collected by inpatient rehabilitation facilities.

⁶ Swing Bed: Assessment data collected by swing bed facilities.

⁷ Age is calculated based on the age of the Medicare beneficiary as of December 31, YYYY. If the beneficiary expired, age is calculated based on age at the time of death.

⁸ The state-reported dual status code (variable called DUAL_STUS_CD_MM) is used to identify beneficiaries dually enrolled in Medicare and Medicaid. Dual coverage was defined as DUAL_STUS_CD_MM = 01, 02, 03, 04, 05, 06 or 08 for 11 or 12 months of the year, or until time of death. Of those, a beneficiary was considered a Full benefit dual if they had DUAL_STUS_CD_MM = 02, 04 or 08 for a minimum of one month during the year. All other duals were considered partial.

⁹ Race variable is calculated using the RTI race categories.

NOTE: The beneficiaries included in these counts may have any combination of Medicare coverage, including full or partial fee-for-service and/or HMO coverage. The application of coverage restrictions/criteria will impact the size of these samples.
